RMEF 2025 Gun-Day Monday Sweepstakes
Official Rules

1. NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.
2. Eligibility: Open only to legal residents of the fifty United States and the District of Columbia, who are age 21 years or older at time of entry, except that the Sweepstakes is void in WA and where prohibited by law. Employees of the Rocky Mountain Elk Foundation ("RMEF" or "Sponsor") and their immediate family members (parents, children, spouse, siblings), prize providers and collectively each of their respective parent companies, affiliates, subsidiaries, advertising and promotion agencies, sales representatives and/or distributors, and their immediate families, and those living in the same household (whether related or not) are not eligible to enter. The RMEF 2025 Gun-Day Monday Sweepstakes ("Sweepstakes") begins at 9:00 a.m. Mountain Time ("MT") on October 2, 2025 and ends at 11:59 p.m. MT on December 31, 2025 ("Sweepstakes Entry Period"). Please remember to account for the time difference from your local time zone when entering online.
3. How To Enter: There are three (3) methods of entry. Method #1: To enter by mail from a personalized offer you received, complete and return your Official Entry Form per the instructions provided, including one Sweepstakes Entry Ticket you select, with or without including a donation. Method #2: To enter online and make a donation (except for residents of MN who should follow Method #3 below in lieu of online entry) visit www.rmef.org/gun26_win. An RMEF account is required to log-on and enter online. If you do not have an RMEF account, create one for free at www.rmef.org/myrmef, and then follow all online entry instructions to enter the Sweepstakes, including selecting the Sweepstakes Entry Ticket you wish to submit, and making a donation. Method #3: To enter by mail (as a free alternate entry method) with or without making a donation, download the RMEF 2025 Gun-Day Monday Alternative Mail-In Entry Form at shop.rmef.org/app/uploads/2025/08/Alternative-Entry-Form_2025_Gun-Day-Sweepstakes.pdf and then follow all instructions to enter the Sweepstakes, including printing both the Information Form and the Sweepstakes Entry Tickets, cutting both to the final entry size noted on the form, hand-printing all information requested on the Information Form and the Sweepstakes Entry Tickets, and mailing both in a #10 envelope via First Class U.S. Mail to: Rocky Mountain Elk Foundation "RMEF 2025 Gun-Day Monday Sweepstakes Entry," P.O. Box 3894, Missoula, MT 59806. All mail-in entries are limited to fifty-two (52) Sweepstakes Entry Tickets returned per envelope. Non-conforming entries will be disqualified. Use of any automated program, device or bot to enter will result in disqualification. Sponsor is not responsible for late, lost, stolen, damaged, garbled, incomplete, illegible, misdirected or postage due entries. All mail-in entries must be postmarked no later than December 31, 2025, and received by January 5, 2026, and online entries must be received during the Sweepstakes Entry Period. No mechanical reproductions of entries will be accepted. All entries become Sponsor's property and will not be returned or acknowledged. Regardless of entry method there is a limit of four-hundred-twenty-eight (428) total entries per person overall, and a limit of the maximum number of entries per person, per day of 104.
4. Prizes: A total of eight Early Bird Prizes and 52 Weekly Prizes will be awarded as set out below. The Early Bird Prize winners will be selected in a random drawing on or about December 12, 2025 from the valid entries received by the dates indicated here. To qualify for the Early Bird prize drawing, mail-in entries must be postmarked by December 4, 2025 and received by December 9, 2025, and online entries must be received by 11:59 p.m. MT on December 4, 2025. The Approximate Retail Value ("ARV") of each prize is listed below. The Early Bird Prizes will be awarded as follows: One (1) winner to receive one (1) Savage 110 KLYM Rifle in 7mm PRC (ARV of \$2,699.00); One (1) winner to receive one (1) Silencer Central Banish Backcountry Suppressor (ARV of \$1,590.00); One (1) winner to receive one (1) \$1,000.00 Sitka Gift Card

(ARV of \$1,000.00); and one (1) winner to receive one (1) YETI Hopper M20 Backpack in Olive Green (ARV of \$325.00).

Each Weekly Prize listed below also includes a separate Bonus Prize. Each Bonus Prize consists of a \$250.00 prepaid gift card for online purchase of your choice of Warne optics, bipod, & scope rings, fitments, mounts, etc. at warnescopemounts.com. ARV of each Bonus Prize is \$250.00. The Weekly Prizes and the ARV of each, including \$250.00 for the Bonus Prize ARV in each case, are listed in the chart below. Each potential Weekly Prize winner for that week as indicated on the chart, will be selected by a random drawing held on or about each Monday in 2026 (except in the cases of Monday holidays, in which case the drawing will be done on the next business day) to award that Weekly Prize. Drawing for the January 6th prize will be held on January 13th. Limit of one (1) Weekly Prize plus Bonus Prize per person, except that winners of the Early Bird Prizes will remain eligible for the Weekly Prize with Bonus Prize drawings. Odds of winning any prize depend on the total number of eligible entries received. Total Approximate Retail Value ("ARV") of all prizes offered in this Sweepstakes is \$110,908.60.
